SELECTBOARD MEETING January 9, 2023 7:30 P.M. - MUNICIPAL OFFICE BUILDING - HANOVER, NH

The meeting of the Selectboard was called to order at 7:30p.m. by Vice Chair Rassias. Also present were: Bill Geraghty, Selectboard Member, Joanna Whitcomb, Selectboard Member, Nancy Carter, Selectboard Member, Alex Torpey, Town Manager

Absent: Chair Peter Christie

Vice chair Rassias noted the procedure for public comment.

1. Public Comment

David Vincelette, 93 Lebanon St noted he has been arrested three times recently during the public comment portion of Selectboard meetings. He watched back the videos of the past 5 years of public comment and there was not mention of a 5-minute time limit until Oct 8, 2022. There is some discrepancy between Chair Christie's affidavit and the police affidavit regarding how much time he was given to speak.

There has also been a discrepancy as to whether he has been allowed to speak during other business items on the agenda over the years depending who was chairing the meeting.

He mentioned again topics he has mentioned before such as accusing the Town and Selectboard of criminal acts. He noted his opinion that the meeting minutes are not descriptive enough.

He was asked by the Vice Chair to wrap up his comments after five minutes, but he continued. He commented he has asked questions of the board and the Town Manager that have not been answered.

The Vice Chair asked several more times for Mr. Vincelette to wrap up his comments and step aside so the meeting could continue. He refused to do so initially, but eventually did with the intention of coming back to the table during other business.

2. Review and Consideration of CPCNH Cost Share Agreement

CPCNH will be launching Wave 1 of the Hanover Community Power as of April 1, 2023.

Board members received the following documents:

Cost Share Agreement which include Amendments to the Hanover Energy Aggregation Plan, CPCNH Data Security and Privacy Policy, Energy Portfolio Risk Management Policy, Retail Rates Policy and Financial Reserves Policy

The Selectboard must act on the above on January 9th for the Hanover Community Power to launch with Wave 1 in April of 2023.

Action Requested: Authorize the Town Manager to enter into a Cost Sharing Agreement and Member Services Contract for the Complete Service Bundle with the Community Power Coalition of New Hampshire (CPCNH) with a delegation of an Authorized Officer and with the elections on Page 19 of the Agreement being "Yes";

- 1) approve the CPCNH's Date Security and Privacy, Energy Portfolio Risk Management, Rates, and Financial Reserves Policies, and
- 2) approve the amendments to the Electric Aggregation Plan for Hanover Community Power as presented in the Agenda packet.

Selectboard January 9, 2023

Pete Kulbacki, Public Works Director, presented the item. Two members of Sustainable Hanover were also in attendance. The essence of the project is the Town will launch aggregate power for the residents. These documents provided need to be adopted for Hanover to join the group that will handle the launch.

Mr. Kulbacki gave the board a lengthy presentation on the item.

Selectboard Member Geraghty commented on the immense work that has gone into this project. July 13, 2021 Town Meeting approved a document and Selectboard has since approved it, but in the one supplied this week there have been changes. When were the changes made- before or after the vote?

Mr. Kulbacki explained the changes and why they were made after the vote.

He also clarified the opt-out vs the opt-in option for Hanover residents.

Mr. Kulbacki clarified for the board "Authorized Officer" is not a full -time job, it is someone to act on behalf of the board with the Coalition.

Yolanda Bumgardner of sustainable Hanover gave reasons why this is a positive benefit to the Town.

3. Recommendation to Set Public Hearing on Monday, January 23, 2023 to Accept Unanticipated Funds from InvestNH Municipal Planning and Zoning Grant Program in the amount of \$75,000.00

The Planning and Zoning Department has applied for a Housing Opportunity Planning Grant in the amount of \$75,000 to implement a campaign of public outreach to educate the community on the need for additional affordable housing and show how affordable housing can be done in a way that doesn't reduce property values or have adverse effects on the local neighborhood or the town as a whole.

The State of New Hampshire has begun issuing employer contribution reimbursements to New Hampshire Retirement System participating employers. The Town of Hanover is expected to receive \$81,384.71 in reimbursement. As these are unanticipated funds, a public hearing must be held.

ReVision Energy agreed to provide 1% of their solar installation sales to the Town of Hanover for their Solarize efforts for the 2022 season. These funds are to be held in a town reserve account designated for installing renewable energy systems at affordable housing units in Hanover.
